Chapter 1. General Provisions

Article 1 (Purpose)

The purpose of these genera terms and conditions is to set forth relevant matters on use conditions and procedures for all services provided by the prior entry system for quarantine information of the Korea Disease Control and Prevention Agency (hereinafter refer red to as "System"), and any other necessary matters.
